Supportive Service Providers & Reentry Resources

- [Atlanta Center for Self-Sufficiency](#) – The mission of ACSS is to empower homeless and financially vulnerable individuals to become self-sufficient and sustainably employed contributors to society. ACSS offers several career focused programs that include job coaching, career placement, and continued support after employment.
- [Center for Employment Opportunities](#) – CEO is a non-profit agency that provides services to formerly incarcerated individuals to assist with barriers that hinder employment. CEO provides job readiness training, transitional employment, job coaching, permanent job placement, and retention services by using their model to reduce recidivism and increase employment.
- [City of Refuge](#) – City of Refuge is a non-profit agency that assist individuals in homeless individuals in crisis by collaborating with on-site partners to offer food, housing, emergency healthcare, education, job training, and financial literacy on the journey to self-sufficiency.

- Dept. of Community Supervision [Community Coordinators](#) – Community Coordinators work in their assigned DCS (probation/parole) circuit to develop and maintain relationships with service providers and resources to assist returning citizens with referrals to housing, employment, mentoring resources, etc.
- [First Step Staffing](#) – First Step Staffing is a non-profit agency that assists with reducing barriers to reentry in the workforce for homeless individuals, military veterans, and individuals who were previously incarcerated. These services include job placement and coaching, rides to and from work, and housing placement assistance.
- [Georgia Works!](#) – Georgia Works is a non-profit agency that works with homeless men to overcome barriers and become self-sufficient individuals. Georgia Works offers housing at their facility for up to a year, as well as transitional work, personal support, case management, workforce training, GED courses, financial literacy, and AA/NA classes.
- [Goodwill of North Georgia](#) – The mission off Goodwill of North Georgia is to put people to work. They offer short term training for anyone interested in gaining a skilled credential.
- [Opportunity ATL](#) – Opportunity ATL is a program sponsored by the Metro Atlanta Chamber that works to connect jobseekers to employment, training, support services, and soft skill development programs.
- [ReNforce](#) – ReNforce provides training and coaching for businesses looking to hire system-impacted people to meet their workforce needs, while simultaneously providing unique training and professional development to improve employment outcomes for career-seekers.
